Background - Comprehending and Reclaiming State Citizenship

Part of our journey to reclaim our personal liberty in the framework of our Constitutional Republic is to comprehend how the shift from "State Citizens" to "14th Amendment citizens" has altered the lawful standing of individuals in the United States; and why it is necessary for Americans to reclaim their State Citizenship status in law, especially those who wish to hold public office.

Prior to the Civil War, *State Citizenship* (capital C) was understood per the Declaration of Independence to be "*United Colonies, are, and of Right ought to be Free and Independent States.*" They absolved all allegiance to the British Crown, and all political connection. It was never the founders intent to compact under the Constitution for the United States to return to the same tyranny. To insure and enjoy their God-given unalienable rights, liberty, and immunities the colonies/States delegated only certain limited, defined, and specific authorities to the federal government.

However, after the Civil War, there were questionable changes to the Constitution of the United States that mysteriously removed the original 13th Amendment (regarding penalties for titles of nobility,) and replaced it with the Amendment abolishing slavery. Then certain "cunning, ambitious, and unprincipled men" added the 14th Amendment regarding 'US citizenship' (small c). This *14th Amendment* citizenship, while instrumental in extending citizenship to all "persons" born or naturalized in the United States[1], cleverly tied citizenship directly to federal (and foreign corporate) authority in contrast to the earlier protections provided by individual State constitutions[2].

The Consequences of 14th Amendment Citizenship

This was a profound structural shift in who we are as Citizens. By placing individuals directly under federal jurisdiction, this citizenship usurped the sovereignty of State Citizens. We now see "unalienable rights" being replaced with "privileges."

Judiciary Implications

"The natural liberty of man is to be free from any superior power on Earth, and not to be under the will or legislative authority of man, but only to have the law of nature for his rule." - Samuel Adams.

"The judiciary of the United States is the subtle corps of sappers and miners constantly working underground to undermine our Constitution from a co-ordinate of a general and special government to a general supreme one alone. This will lay all things at their feet. ... I will say, that "against this every man should raise his voice," and, more, should uplift his arm ... — Letter from Thomas Jefferson to Thomas Ritchie, Sept. 1820

A lawful and honorable judicial system is a necessary foundation of our nation. The current judicial system in America has been distorted to control, manipulate, and indoctrinate the people, and has been obstructing justice. The courts are used to uphold corporate laws and have replaced *due process* with a monetary system that protects the interests of international bankers, corporate pirates, with ties to the *British Crown* through attorneys and judges doing their bidding. They have breached the trust to our Constitution.

The American People have been enslaved by a perverted and corrupt system of judges, attorneys, and law enforcement agencies in collusion with other corporate entities against the American People, since the 1860's. Our laws have become complicated and convoluted, many under the guise of protecting you and the collective good of public safety. Your individual rights are supplanted by collective rights (communism.) What this means

is that your “un-alienable rights” are lost in the regulations, the deluge of dos and don’ts wherein your rights have been replaced with privileges.

Adhesion Contracts

Many Americans unknowingly have contracted with the corporatized UNITED STATES GOVERNMENT through various mechanisms both deceptive and undisclosed, in adhesion contracts such as: Birth Certificates (resulting in the ALL CAPS NAME,) Social Security, driver’s licenses, and bank accounts. To regain our standing as State Citizens in the original *de jure* Republic, it is necessary for individuals to take specific steps, including renouncing these adhesion contracts and reaffirming their allegiance to the Republic to regain their lawful standing.

Examples of individuals who would need to take these steps include:

1. Anyone with a Certificate of Live Birth, which results in a fraudulent, secret, and monetized Birth Certificate.
2. Anyone with a Social Security number... you get it, almost every American.
3. Anyone who has obtained a STATE driver’s license, hunting or fishing license.
4. Anyone who has opened a bank account.
5. Any lawful/legal immigrant who has been naturalized.
6. Anyone who has been employed by the corporatized UNITED STATES GOVERNMENT.

Original 13th Amendment

The original 13th Amendment[3], prohibits “Titles of nobility or honour,” (such as BAR Attorneys with title “Esquire”) and also includes members of Secret Societies, from holding office. They have lost their Citizenship and will need a pathway to restore their status by first renouncing such titles and affiliations.

NOTE: In order to enforce the original 13th amendment those bearing a “title of nobility or honour” [3] will NOT be allowed to hold interim offices in the Republic. The same applies to members of secret societies, which are full of “*cunning, ambitious, and unprincipled men,*” that have historically twisted and manipulated history, and threatened the very existence of the Republic.

Restoration of State Citizenship and the Oath of Allegiance

The following oath is a requirement for any national and Territory/State interim positions appointed by the President, recommended to him by the Governors, and vetted by the Senate per the Northwest Ordinance. Those appointed to county or Territory/State interim offices by your Governors must determine their own requirements to reestablish their lawful standing as State Citizens per each individual Territory/State guidelines consistent with the US Constitution. This oath is simply one way that we can all demonstrate that we are joint heirs to that which our Forefathers gave us, a Constitutional Republic of free States in union, free from entanglements.

Such groups and philosophies include, but are not limited to, Freemasonry, Scottish, York Rites, Women’s *Masonic* and *Shriners* organizations; all secret societies; Communism, Marxism, *Sharia law* and its courts; and Islamic teaching at any and all levels.

In the instance where this Affiant has previous association or affiliation with one of the above groups, I attach (a) witnessed documentation attesting both verbally and in writing that I have publically renounced said affiliation.

I do solemnly swear (or affirm) before Almighty God, that the foregoing is true and correct, and that I am a natural-born Citizen (b) of the united States of America, born on the _____ free-State. These statements are made under the full weight and solemnity of my word and honor. I take this oath freely, without duress, and of my own volition, agreeing to hold myself accountable to the terms, consequences, and penalties thereof.

In the beginning God said; therefore be it known to all men and women (hereafter both genders denoted simply as Men), that it is self-evident that all Men are created equal, endowed by our Creator with certain unalienable sovereign rights to which the Laws of Nature and Nature's God entitle them. To secure these sovereign rights, governments are instituted among Men, deriving specific limited delegated powers from the consent of the governed.

A Constitutional republic is established when We the People assemble as a "civil body politic" with county, state, and national representation to thereby secure these rights of life, liberty, and the pursuit of happiness as laid out in our nation's Declaration of Independence. In the Republic, we establish by Constitution, certain authority derived from the People's unalienable sovereign rights held in trust through lawful government that is founded in compact, and thereby delegate specific limited surrogate power to elected officials.

The local county is the natural level for the People to assemble themselves to identify and raise up fellow citizens who will ensure that these limited powers are restricted and to ensure elected officials guard with sacred trust the unalienable rights of We the People. These elected officials are and shall forever remain servants of the People. They may never usurp power through legislative, executive, judicial, nor administrative function; for We the People, under God are sovereign in America. Any attempt to invert a Republic into a democracy by Corporatism or otherwise, corrupts the authority of our guaranteed republican form of government and is abhorrent to every principle of liberty. Therefore, I declare by Almighty God in peaceable compact, to wit:

I am created equal to all Men with inherent sovereign rights held in covenant. I therefore solemnly publish and declare: I am absolved by this declaration from all political allegiance foreign to the Republic for the united States of America. Therefore, with a firm reliance on the protection of Divine Providence, in compact with the Republic, I swear or affirm:

I am lawfully natural born or lawfully settled on _____ County on _____ free-State. In order to form a more perfect Republic/Union, establish justice, insure domestic tranquility, provide for the common defense, promote the general welfare, and secure the blessings of liberty for our Republic and our posterity; I consent in Compact to delegate certain authority derived from my unalienable rights held in covenant, to the Republic by Constitution; in exchange for the protections, freedoms, rights, and lawful recognition as being free in the Republic for the united States of America. Therefore, in support of this Declaration, with a firm reliance on Divine Providence, I hereby pledge to guard and preserve the Republic. By autograph with witnesses this Declaration of Sovereign Rights is absolute supreme in the Republic.

Declaration of Independence, July 4, 1776, and circa 2010

When in the Course of human events, it becomes necessary for one People to dissolve the political bands which have connected them with another, and to assume among the powers of the earth, the separate and equal station to which the Laws of Nature and of Nature's God entitle them, a decent respect to the opinions of mankind requires that they should declare the causes which impel them to the separation.

We hold these truths to be self-evident, that all Men are created equal, that they are endowed by their Creator with certain unalienable Rights that among these are Life, Liberty, and the pursuit of Happiness. That to secure these rights, Governments are instituted among Men; deriving their just powers from the consent of the governed. That whenever any Form of Government becomes destructive of these ends, it is the Right of the People to alter or to abolish it, and to institute new Government, laying its foundation on such principles, and organizing its powers in such form, as to them shall seem most likely to affect their Safety and Happiness. Prudence, indeed, will dictate that Governments long established should not be changed for light and transient causes; and accordingly all experience hath shown, that mankind are more disposed to suffer, while evils are sufferable, than to right themselves by abolishing the forms to which they are accustomed. But when a long train of abuses and usurpations, pursuing invariably the same Object, evinces a design to reduce them under absolute Despotism, it is their right, it is their duty, to throw off such Government, and to provide new Guards for their future security. Such has been the patient sufferance of these Colonies; and such is now the necessity which constrains them to alter their former Systems of Government. The history of the present King of Great Britain is a history of repeated injuries and usurpations, all having in direct object the establishment of an absolute Tyranny over these states. To prove this, let Facts be submitted to a candid world.

We, therefore, the Representatives of the united States of America, in General Congress, Assembled, appealing to the Supreme Judge of the world for the rectitude of our intentions, do, in the Name, and by Authority of the good People of these Colonies, solemnly publish and declare,

That these United Colonies are, and of Right ought to be, Free and Independent States; that they are Absolved from all Allegiance to the British Crown (including all foreign powers to this Republic circa 2010) and that all political connection between them and the State of Great Britain, is and ought to be totally dissolved; and that, as Free and Independent States, they have full Power to levy War, conclude Peace, contract Alliance, establish Commerce, and do all other Acts and Things which Independent States may of right do.

And for the support of this Declaration, with a firm reliance on the protection of Divine Providence, we mutually pledge to each other our Lives, our Fortunes, and our sacred Honor.

See "... without imposing or endorsing a national religion, do hereby continue the adoption of the accurate "Holy Bible" as divine law and the fundamental basis of law form." (Declaration of Sovereign Intent c. November 14, 2010 - Notice of Abolishment Section I.)*

Non-Disclosure Agreement and Database Confidentiality

This Confidentiality & Non-Disclosure Agreement (“Agreement”) is made and effective on date of appointment _____ by and between The Republic for the united States of America (“Republic”) and _____, (“Living Man/Woman”) on _____ free State. This agreement is for direct or indirect access to Republic databases.

1. Confidential Information - Certain confidential and proprietary information may, from time to time, be disclosed (the “Confidential Information”) to Living Man/Woman. Confidential Information shall include all data, data on website RepublicfortheunitedStatesofAmerica.org, and all other Republic websites, materials, products, technology, computer programs, specifications, manuals, plans, software, marketing plans, business plans, financial information, issues of Security relating to the Republic or any Sovereign and other information disclosed or submitted, orally, in writing, or by any other media, to Living Man/Woman by Republic. All information released to any parties as Living Man/Woman’s or Authorized Presenter is binding by this Agreement if information is disclosed to Living Man/Woman as Confidential Information.

2. Living Man's/Woman’s Obligations

(a) **Living Man/Woman’s Treatment of Confidential Information** – Living Man/Woman agrees to hold the Confidential Information in confidence, shall not use the same in other than the purposes of its duties with and for Republic. Living Man/Woman will not disclose, publish or otherwise reveal any of the Confidential Information received from or disclosed to Living Man/Woman by Republic to any other party whatsoever, except with the specific prior written authorization of the Republic.

(b) **Tangible Confidential Information** - Confidential Information in tangible (physical) form shall not be duplicated by Living Man/Woman except for purposes normally required in their duties, by and for the Republic. Upon the request of the Republic, Living Man/Woman shall return all Confidential Information received in written, electronic, photographic, or tangible form, including copies, or reproductions or other media containing such Confidential Information, within ten (10) days of such request. At Living Man/Woman’s option, any documents or other media developed by the Living Man/Woman containing Confidential Information may be destroyed. Living Man/Woman shall provide a written certificate to Republic regarding destruction within ten (10) days following the destruction.

(c) **Exceptions** - The foregoing obligations and restrictions do not apply to that part of the Confidential Information that Living Man/Woman demonstrates:

i. Confidential Information was available or became available to the public other than as a result of a disclosure by Living Man/Woman or through a known breach of confidentiality owed to Republic by the disclosing party;

ii. If Confidential Information was requested or legally compelled for a civil or criminal investigation, then Living Man/Woman shall provide Republic with prompt notice of any requests so that Republic may seek an appropriate protective order or other appropriate remedy, and provide reasonable assistance to the Republic in obtaining any such protective order. If such protective order or other remedy is not obtained or Republic grants a waiver hereunder, then Living Man/Woman may furnish that portion (and only that portion) of the Confidential Information which is reasonably acceptable to Republic, Living Man/Woman is compelled or is otherwise required to disclose; provided, that Living Man/Woman shall The Republic for the united States of America use reasonable efforts to obtain reliable assurance that any Confidential Information that is disclosed will be treated confidentially.

3. Term - The obligations herein shall be binding upon Living Man/Woman for five (5) years from the date Republic last discloses any Confidential Information to Living Man/Woman pursuant to this Agreement.

4. No Publicity - Living Man/Woman agrees not to disclose, the existence or terms and conditions of the Agreement, or the fact that discussions are being held with Republic.

5. Governing Law and Equitable Relief - This Agreement shall be governed and construed in accordance with the laws of the Republic and the Living Man/Woman's Republic free-State, so identified by the "Agreement" autographs at the end of this "Agreement." Living Man/Woman consents to the exclusive jurisdiction of lawful courts of the Republic and the lawful courts of the Living Man's/Woman's Republic State, so identified by this "Agreement" for any dispute arising out of this Agreement.

6. Notices - Any notice required by this Agreement or given in connection with it, shall be in writing and shall be given to the appropriate party by personal delivery or by certified mail, postage prepaid, or recognized overnight delivery services.

7. Entire Agreement - This Agreement terminates and supersedes all prior understandings or agreements on the subject matter hereof. This Agreement may only be modified by a future writing executed by both parties.
